1. To hold a Dog/puppy with the **intent to purchase** a Puppy/dog by the time the puppy reaches _____ of age. Purchaser understands and agrees that the holding fee is non-refundable.

Purchaser *understands and agrees to the terms and conditions and that the holding fee is non-refundable.*

2. Purchaser agrees to **price** \$_____ for the litter of preferred Dam #1/Dog/Puppy and/or price limit between \$: _____ - _____ minus the holding fee (+Sales tax if applicable.) if deferred to another litter based on availability or personal choice before the puppy reaches 6 weeks of age. (Price varies by litter, we agree to price range or price limit at the time holding fee is to be placed, if 1st litter/dog/puppy is deferred.)

3. Purchaser understands completion of puppy **payments** must be by _____ for selected litter/dog/puppy. Payments can be through Zelle, Good Dog, Cash, or Check. (P.O. Box 26 Upperco, MD 21155)

4. Purchaser understands that arranged dog/puppy **pick-up** will be by _____ /or _____ weeks of age. Purchaser is responsible to pay for transport.

(**Extended care:** If applicable) Puppy dog will be boarded with Seller until _____ / _____ (days) a fee of \$70.00 a day. After this day/time puppy/dog will be resold with refund at the discretion of the Golden Ridge Farm, LLC. Golden Ridge Farm, LLC will not be held liable for any incidents or vet care during extended care, unless noted here: _____.

Purchaser *agrees puppy will be **picked up** by _____ /or _____ weeks of age or Purchaser will be responsible for extended care daily fee. Purchaser will be responsible for all costs associated with picking up the puppy from Golden Ridge Farm, LLC*

Purchaser *agrees for **extended care** through Date: _____ & Purchaser will be responsible for any vet expenses incurred from 8 weeks of age until date mentioned above.*

5. Purchaser is not guaranteed puppy **of choice** or gender of choice or selection order; however, Purchaser understands that Purchaser can continue to defer place in line and add to future reservation lists until Purchaser gets the puppy of want and /or need. Purchaser understand this decision must be made before the puppies reach 6 weeks of age for up to 1(One Year) or holding fee will be forfeit.

Purchaser *understands and agrees to the terms and conditions about puppy of choice.*

6. Purchaser also understands that **the timing** of litters is uncontrolled, as well as a successful pregnancy, sex and/or quantity of puppies. Golden Ridge Farm , LLC is not able to control the timing of heat cycles, the timing of litters, successful pregnancy, sex and/or quantity of puppies. Golden Ridge Farm, LLC also reserves the right to move a reservation due to the best interest of the puppy, unavailability of quantity, sex or desired traits of Purchaser or the cancellation of the litter's parents involved (the health of parent dogs is paramount to having a litter). In the event a reservation list (breeding pair) is cancelled and or unavailable puppy. Purchaser will be moved and placed on second preferred Dam's reservation list and/or given other upcoming litter/dog/puppy options within the price limit agreed to above.

Purchaser *understands and agrees that **timing** is never guaranteed.*

7. Purchaser understands that Purchaser **selection** is in the order of the reservation list. If a Purchaser is not in attendance nor is reachable by phone during the planned puppy selection day in the purchaser's appointment time of 1 hour, then purchaser will forfeit their placement.

Purchaser *understands and agrees to the **selection** process.*

8. I understand that **Golden Ridge Farm, LLC reserves the right** to reserve and pick any puppy selection in any form or fashion without restriction. Golden Ridge Farm, LLC also reserve the right to replace a puppy of our own selection.

I *understand and agree to **Golden Ridge Farm German Shepherds, LLC reserves the right** to reserve and pick a dog/puppy any form or fashion they choose.*

9. Purchaser has 72 business hours to take dog/puppy to the **vet** to confirm dog/puppy is in good health. Dog/Puppy should be seen in this time frame to establish vet care in case of an emergency.

Purchaser understands Purchaser has 72 business hours to have the dog/puppy seen by a **vet** of their choice to confirm the dog/puppy is in good health.

10. Golden Ridge Farm, LLC reserves the right to void this transaction and refund the holding fee if it is learned that for any reason why the Purchaser might **not be suitable for a dog/puppy**. (i.e., purchaser is found to be an animal abuser, violent, ill intentions with the dog such as fighting, representee of pet store, or research laboratory etc.)

11. By signing below, Purchaser states that he/she has read the forementioned Reservation Contract Holding Fee & had the opportunity to read the Dog/Puppy Contract that will be signed at the time of transfer and is in complete agreement. The Purchaser agrees that he/she understands this contract fully and understand this contract is under the jurisdiction of the State of Maryland, in Carroll County. It is agreed that the place of Venue shall be in Carroll County, Maryland.
